Detention Time

Detention time is defined as any unreasonable detention of truck for the purpose of loading or unloading. Unreasonable detention is defined as truck being held for more than two hours beyond time of arrival at loading or unloading point, unless there is a scheduled appointment time in which case detention will begin two hours from scheduled appointment time. Should equipment be detained by more than the specified two hours detention compensation will be figured from time of arrival or the scheduled appointment time. Detention will be billed at \$150 per hour, up to a maximum of \$1,500 per day. Should said detention interfere, in any way, with a previously scheduled load booked to follow the detained load you will also be responsible for any fines, penalties or loss of revenue due to said load, on top of specified detention compensation.
